PUBLIC NOTICE

RE: A REMINDER FOR APPLICATION FOR PRACTICING CERTIFICATE TO ENVIRONMENTAL EXPERTS

- 1. Section 83 of the Environmental Management Act, 2004 directs that the Environmental Impact Assessments and Environmental Audits shall be conducted by Experts or Firms of Environmental Experts whose names and qualifications have been registered as such by the Council. In addition, Regulations 27 and 30 of the Environmental Management (Registration and Practice of Environmental Experts) Regulations, 2021 (published by GN N0.267 on 19th March, 2021) confer powers to the Council to issue Practicing Certificate to qualified Individuals and Firms as Environmental Experts and Firm of Environmental Experts respectively.
- **2.** Therefore, the Council hereby reminds the eligible Firms of Environmental Experts and Individuals to apply for Practicing Certificates.
- 3. Be also reminded that, all applications and payments are conducted online through eia.nemc.or.tz. Non-refundable application fee is Fifty Thousand Tanzanian Shillings (TZS 50,000/=) and the fee for Practicing Certificate of individual citizen is Two Hundred Thousand Tanzanian Shillings (TZS. 200,000/=) and One Million Tanzanian Shillings (TZS 1,000,000) for Firms of Environmental Experts.
- 4. Every Firm applying for practicing certificate should among other requirements:
 - i. Provide copy of certificate of registration as a Firm
 - ii. Have at least two lead experts with practicing certificates.
 - iii. Clear all outstanding fees and charges.
 - iv. Provide Certificate of Incorporation, valid business license and TIN
- 5. Every individual applying for practicing certificate should among other requirements:
 - i. Provide copy of certificate of registration as an individual expert
 - iii. Clear all outstanding fees and charges.
 - iv. Provide valid business license and TIN

v. Provide proof of conduct/participation of EIA/EA studies to support relevant category

Please note that, from 15th October 2023, No Firm of Environmental Experts will be allowed to conduct EIA/EA studies without Practicing Certificate.
