Based on Regulation 24(1) of the Environmental Management (Registration and Practice of Environmental Experts) Regulations, 2021, “A *registered environmental expert in any category shall not conduct any environmental study without a practicing certificate issued under these Regulations*”. In this regard, the following is the list of Environmental Experts eligible to Practice for Environmental Impact Assessment (EIA) and Environmental Audit (EA).
