1. The Government of the United Republic of Tanzania has received funds from the World Bank toward the cost of the Environmental Health and Pollution Management Project (EHPMP) and intends to apply part of the proceeds for consulting services.
2. The consulting services (the Services) includes: Environmental and Social Impact Assessment for the Construction of Gold Ores Processing and Washing Facilities in Mwanza, Geita, Singida, Mara, Songwe, Mbeya and Shinyanga regions. These regions have been divided in three lots (Lot 1 – Mwanza, Geita and Mara; Lot 2 – Singida and Shinyanga; and Lot 3 – Songwe and Mbeya).
3. The National Environment Management Council (NEMC) now invites eligible individual/consulting firms (“Consultants”) to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the services. The shortlisting criteria: (a) Individual/firm registered by NEMC as environmental expert for undertaking ESIA studies; (b) Individual/firm have qualified team of professionals and support staff to be deployed to execute the assignment; and (c) Individual/firm have experience in various World Bank funded projects and implementation of World Bank Environmental and Social Standards. Other criteria are available in ToR.

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank's Guidelines: Selection and Employment of Consultants [under IBRD Loans and IDA Credits & Grants] by World Bank Borrowers January 2011 ("Consultant Guidelines"), setting forth the World Bank's policy on conflict of interest.

4. Consultants may associate with other firms in the form of a joint venture or a sub-consultancy to enhance their qualifications.
5. A Consultant will be selected in accordance with the Consultants' Qualification Selection (CQS) method set out in the Consultant Guidelines.
6. Consultants may apply for a lot or all lots. The award will be given per Lot.
